


How to find and “purchase” the Free Ethics Video-on-demand

1. Go to the Alaska Bar Association home page: www.alaskabar.org and log-in to your member dashboard.

Your username and password are case sensitive. Type your information into the proper fields then click on the blue [ALASKA BAR MEMBER LOGIN](#) button

If you are a Bar Member and do not know your username and password try this formula first:

Username: Enter your Bar Number and last name in all lowercase i.e. 1234567smith

Password: Enter the first 3 letter of your last name in lowercase and your EIGHT digit date of birth (mm/dd/yyyy) i.e. - smi12301965




