Dear Senator Murkowski:

I write to express my interest in an open vacancy on the Alaska federal district court. I am a dedicated public servant, having spent the first six years of my career in federal service as a law clerk and a federal prosecutor and the last thirteen plus years in state service as a civil litigator. I intend to finish my career in public service, and I would be honored to serve the State of Alaska as one of its federal district court judges.

I am applying because I believe I can be of service to the State of Alaska. The simple truth is Alaska is different, and I have spent my career at the Alaska Department of Law litigating cases to protect those differences and the State's statehood entitlement. And, more importantly, I have had success. When I started at the Department of Law, I focused on quieting title to the State's submerged lands. I litigated a dispute with the federal government over the Mosquito Fork River from start to finish and built a case so strong that the United States disclaimed its interest on the eve of trial. I then persuaded Judge Gleason that the United States had acted in bad faith by presenting frivolous arguments and she awarded the State attorney's fees. *See Alaska v. United States*, 2016 WL 1948801 (D. Alaska 2016). Most recently, I received a partially favorable decision in litigation challenging the Secretary of the Interior's authority to take lands into trust in Alaska. Although Judge Gleason found the Secretary retained some lands-into-trust authority, she agreed with the State's position that Interior must apply a more limited definition of "Indian" and that Interior cannot rely on the Tribe's traditional homeland as support for its decision. *See Alaska v. Newland*, 2024 WL 3178000 (D. Alaska 2024). Even if the Ninth Circuit upholds her decision on the Secretary's authority, this should provide some guardrails around that authority.

I also have experience with federal criminal practice. I spent the first three years after my clerkship working for the Department of Justice as a federal prosecutor. I tried twelve bench trials and two jury trials during this period. And, during my three-year clerkship, I assisted Judge Tallman with multiple criminal appeals. I will use this criminal experience as a foundation to build from should I join the bench.

Last, I understand and wholeheartedly accept the responsibility that comes with public service. I am committed to the principles of justice, fairness, and accountability, and I accept the responsibility to protect the public trust. If chosen, I would do what I have always done throughout my life and career; I would act with transparency, and I would hold myself to rigorous ethical standards.

Alaska needs a federal district court judge that has experience with its state-specific statutes and federal jurisprudence. I have that experience, and I hope you will consider me for the position. Attached please find my resume, and I am also happy to provide the application materials that I submitted to Senator Sullivan.

Dear Senator Murkowski:

I am writing to respectfully request your consideration of my candidacy for the vacancies on the United States District Court for the District of Alaska. I have extensive federal litigation experience, including successfully representing the United States in high-stakes constitutional challenges, national security matters, and complex regulatory disputes in federal courts across the country over the course of Presidential administrations of both parties. As Deputy Municipal Attorney for Anchorage, I currently represent the Municipality's interests in matters before the District of Alaska and the Ninth Circuit, including cases involving critical public safety issues. My career in public service has given me tremendous pride and satisfaction in diligently applying my legal acumen to helping resolve difficult disputes with integrity and overriding respect for the rule of law. It would be an honor to continue doing so, but in a different capacity as a federal judge.

My legal career began here in Alaska clerking for then-Chief Justice Dana Fabe after graduating *magna cum laude* from Harvard Law School. That clerkship is where I learned how unique this State is in law and life. The challenges we face in Alaska have often led to novel legal solutions in the form of federal statutes governing land ownership, resource development, and Alaska Natives. In our short history as a State, we have been blessed by a world-class bench and bar that have risen to the challenges we face. As Chief Justice Roberts famously observed, and as every brief to an Outside court about an Alaska issue has noted ever since, "Alaska is different." I am thankful every day that I lucked my way into this special life, where I met my wife on a hike up Crow Pass, and this legal community, where I currently serve on the board of the Alaska chapter of the Federal Bar Association and help organize bench-bar events.

After starting our legal journey here in Alaska, my wife and I briefly moved to DC where I launched what would become nearly a decade-long career as a DOJ litigator. After just a few years in DC, we had the good sense to come back to Alaska to make our forever home and raise our children. I was given special permission during the first Trump administration, before the pandemic, to work remotely from Alaska while continuing to take the lead on some of the federal government's most sensitive, complex, and important cases, including matters of national security and administration priorities, such as cases involving state secrets, foreign intelligence surveillance, military aid to Israel, the defense of Executive Orders, and the constitutionality of major bipartisan federal statutes. That worked earned me U.S. Attorney General Jeff Sessions' John Marshall Award for Outstanding Legal Achievement and a Special Commendation for Outstanding Service. By the time I left DOJ, I had filed over 100 significant motions and briefs in 56 cases in federal courts across the country.

I am now honored to serve as Deputy Municipal Attorney for Anchorage. In that role, I directly supervise and conduct all civil litigation on behalf of the Municipality in federal and state courts, particularly the U.S. District Court for the District of Alaska. I also advise municipal leadership on an astoundingly broad range of legal matters that come before the city every day. This job gives me the opportunity to devote my legal talents to making my town better in tangible ways that my family

and I can see every day. A very significant part of my job involves navigating the intersection of federal law with state and local law in the unique context of Alaska, with our special needs and often special legal frameworks. That experience has given me valuable insight into the real-world impacts of federal judicial decisions on local businesses and communities and the importance of making sure our bench maintains the highest level of professional capability, integrity, and diligence.

Public service is a calling, and any lawyer fortunate enough to be selected from the long list of those qualified to sit on the bench should feel grateful for the opportunity to serve. I certainly would. My career as a litigator has instilled in me a reverence for the rule of law as a bedrock principle in our country and for the essential role of the judge in upholding that value. Much of the greatness of our modern world rests on the rule of law. It would be an honor to continue in the tradition of upholding the rule of law for the next generation. But I must admit I also have a more personal, less lofty interest in serving: I am a huge legal nerd. I have never met a case or legal issue, big or small, that I did not find interesting. I can think of no more interesting job than one that feeds me a constant diet of new legal and factual issues to resolve to the best of my abilities.

Dear Sen. Murkowski,

I am interested in the federal district court vacancy because I want to restore faith in our nation's judiciary, and I believe my résumé might help.

I went to Vermont Law School because it was the top school for environmental/resources law for two of my three years there. I was already on the east coast and saw it as an opportunity to be back in the woods and close to skiing. Having grown up in Homer/Anchor Point, my goal was to return home to Alaska and become in-house counsel to an oil company, a mining company, or an Alaska Native corporation involved in resource development to counsel them on environmental compliance.

I did not want to be a trial attorney upon graduating from law school let alone a judge, but my career path is full of unanticipated curves. For starters, Frank Murkowski ran for Governor, so I was honored when the Attorney General called while I was finishing my JD to ask if I could be his Special Assistant. Less than two years later, the Governor drafted me into his personal office to handle a legal/policy portfolio. My own circumstances at the end of that administration required me to remain a state employee, so I moved back to the Department of Law to become a DA and earned my stripes as a trial attorney. After almost 5.5 years, I took the opportunity at Reeves Amodio to work on environmental permitting and spill cleanup issues. I also accepted some of the firm's general practice areas and capitalized on my litigation experience. Except for family law and criminal defense (and I did some of these cases anyway), I saw the gamut of clients: estates, real estate/property, transactions, corporate issues, contracts, complex commercial disputes, spill cleanups, NPDES permitting, torts, insurance, etc.

I was invited back into public service in late 2018 to assist the Dunleavy administration with criminal law reform. With that accomplished and a change in the Chief of Staff, I found myself seeking a new role. This led me to become a civil rights attorney as the Executive Director for the Alaska State Commission for Human Rights. From the outset, and particularly given that I was the sole attorney when I started, I committed to leading the agency from the front by retaining a caseload. I am extremely proud of my five years at the Commission: the agency is restaffed, reorganized, and with efficiencies I implemented, we accomplished a 40-year goal to reduce investigation times to less than a year. It was here in my first few months that an opposing attorney first planted the seed by telling me I should apply for an open judicial seat.

At this point in my career, I have experience providing high-level legal and policy

advice to two administrations, I served as a prosecutor, I represented a wide variety of clients in private civil practice, and I am a civil rights attorney. I proved my worth as a competent trial lawyer and an efficient administrator. I have a working knowledge of ANILCA (I wrote the State's amicus brief in *Hale v. Norton*) and ANCSA, and tried to center as many projects during law school as I could on these laws. I studied environmental/resources law, am published, and have a working knowledge of our resource industries. My depth of legal experience is rounded while simultaneously focused on issues important to Alaska. I am also familiar with Title VII of the Civil Rights Act of 1964.

The bench needs non-controversial appointments consisting of competent attorneys with good moral character, who understand Alaska's needs and our special laws, who have a working knowledge of criminal law, who appreciate representing clients in typical civil disputes, and who can genuinely listen to both sides and give parties a fairly decided and correct decision. I would bring all of this to the bench, and I want the opportunity to play some small role in restoring America's faith in our judicial system.

It is with honor that I write to express my interest in becoming a United States District Court Judge for the District of Alaska. As one of the most senior criminal prosecutors in the Anchorage branch of the U.S. Attorney's office, I have had the privilege of serving Alaska and the United States in a variety of roles, but can think of no higher distinction than joining the federal judiciary.

My nearly 25 years of experiences have provided me with the skillset, judgment, compassion, and respect for the rule of law required to succeed as a federal judge. As an Assistant U.S. Attorney, I have prosecuted countless complex cases, including the highest profile white-collar, corruption, and violent crimes cases, many involving highly vulnerable victims. For instance, I was lead counsel on a \$26 million investment fraud scheme perpetrated on nearly 200 Alaskan victims. I have also handled matters involving oil and gas issues, the fentanyl epidemic, and economic crimes committed in rural Alaska. In 2023, I was awarded the distinguished U.S. Department of Justice Director's Award for my accomplishments.

Prior to the U.S. Attorney's office, I was a partner in the insolvency/restructuring group at the international law firm of K&L Gates LLP, primarily representing distressed businesses and fraud victims. In addition, I have been the keynote speaker at dozens of domestic and international professional events, published multiple articles on civil and criminal topics, and lived in Nepal and the Maldives to assist these countries in developing the rule of law, including, for example, combating human trafficking and establishing fair plea bargaining and public defender systems.

I am committed to serving Alaska's communities as a federal judge. As a father of three school-aged children, an active community member, a fisherman, and a local small business owner, I appreciate the significant impacts federal cases have on our daily lives and would ensure that every citizen has an impartial and respected forum to redress their grievances.

I would appreciate the opportunity to discuss the judicial vacancy with you in person.

With this letter, I am expressing my interest in consideration for one of those vacancies.

I serve as Section lead on federal litigation pertaining to statehood defense and federal overreach, navigability, and RS 2477. 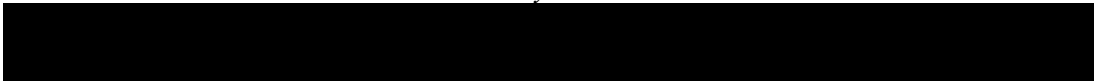

I currently serve as a part-time federal magistrate judge in our District, recently served for six months as a full-time active-duty trial judge in the United States Army, and am now seeking employment as a full-time trial judge in our District.

I offer significant experience as a judicial officer in federal venues. As a civilian, I have served our District since 2009 as a federal magistrate judge that regularly hears criminal and civil matters from different areas of Alaska. In this role, I have worked for years with our court staff and stakeholder agencies to preserve the rights of the parties and ensure the administration of justice. 

My experience in criminal law has afforded me the opportunity to appear regularly in court, conduct jury trials, and litigate complex motions to suppress and dismiss in Municipal, State, and Federal Court. Dear Sen. Murkowski:

This letter is to express my interest in appointment to the Federal District Court. Attached please find my résumé. If there is additional information or materials you would like to review, please let me know. I have also submitted my application to Senator Sullivan through the process he has announced.

In brief, I am a lifelong Alaskan. I was born in Anchorage and have lived here for 42 years, absent only for one year of college in Chicago and three years of law school in Idaho. This is my home. The people I serve at work are my neighbors, and it would be an honor to serve our great state on the federal bench. For the past 2 ½ years I have served on the superior court in Anchorage. Prior to that I was in private practice for 14 years, nearly all of which were spent managing my own law office. I maintained a general practice, from small business and civil litigation to estate planning, criminal defense, personal injury, and all areas of family law. On the bench, I currently have a primarily civil docket, but I also co-preside over a criminal substance abuse probation court, as well as serving as backup for the weekly criminal competency calendar.

I thoroughly enjoy the work of a judge. It is challenging, humbling, and consistently rewarding. It was not a career aspiration of mine to seek the bench. In truth, in law school I thought I wanted to run for governor someday. But my heart is always focused first on helping others, and ensuring access to justice for those who might feel it out of reach. Early on I found my calling serving everyday working people who needed attorneys but their means were modest. Eventually, I gravitated more to the middle of the courtroom, desiring less to argue one side, and more to land on the right outcome—whether it was where my client was standing or not. As a judge I have that freedom. I can focus on ensuring that the law is upheld, that all parties are treated fairly, and that rights are protected.

In criminal litigation, the judge must ensure that rules are followed, defendants are treated as presumed innocent until proven guilty, victims are kept apprised and given a voice, the public is

protected, and resolution must be timely. In Alaska presently, and Anchorage particularly, the saying “justice delayed is justice denied” is truly impacting all sides in criminal cases. As judges, we must be vigilant to address the causes of delay, hold attorneys and parties accountable, and facilitate speedy, but fair, justice.

In civil litigation, delay is just as damaging. In fact, often the lack of a speedy trial “right” akin to that of the Sixth Amendment, allows for delay in civil cases that significantly harms one or both parties. In my current civil caseload, I am very mindful of this and would be that much more so in federal court.

There are many issues facing Alaskans today, both as individuals and collectively, that require action by the courts to resolve, protect, and further our interests. I believe my experience serving Alaskans as an attorney for 14 years and as a superior court judge for 2+ years now have given me the perspective and understanding necessary to serve well on the federal bench. Like many other lifelong Alaskans, I am an incredibly hard worker, energized by daunting challenges, and unfazed by the storms that wash over me. I am blessed to serve on the state bench today, with the support of my family, neighbors, and colleagues. I would be honored to serve our state and country on the federal bench if I am called to that important work.

Thank you for considering me and for taking the time. I know you are busy and I do not take the opportunity for granted.

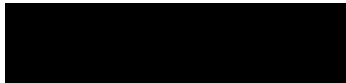
