Member of the National Indian Health Board (NIHB) Medicare & Medicaid Policy Committee, and a technical advisor to the CMS Tribal Technical Advisory Group since their inception.

In other areas of practice, works with Alaska Tribal Health Programs to draft the Community Health Aide Program Standards, including the standards for Dental Health Aide Therapists, and now assists tribes and organizations considering expansion of these services in other locations.
