Subject: **Nominations for a Seat on the Alaska Judicial Council**

The Board of Governors of the Alaska Bar Association is soliciting nominations for the seat on the Alaska Judicial Council currently held by Aimee Anderson Oravec. This is for a six year term ending February 23, 2024. Polling will occur only in the 2<sup>nd</sup> & 4<sup>th</sup> Judicial Districts.

Any **active member of the Alaska Bar who resides in the 2<sup>nd</sup> & 4<sup>th</sup> Judicial Districts** is eligible to fill this vacancy, which is one of Council's three attorney positions. Council members serve staggered six year terms. The Board of Governors makes the appointment after conducting an advisory poll of the 2<sup>nd</sup> & 4<sup>th</sup> Judicial District bar members.

The description of the attorney member Council position prepared by the Alaska Judicial Council is posted on the [Judicial Council's website](#). It outlines the duties and responsibilities of Council members, and is provided as information to prospective attorney candidates.

PLEASE NOTE: Attorneys receiving a salary from the State of Alaska or from the U.S. Government are ineligible for appointment (Alaska Constitution, Article 4, Section 8). The person appointed to the Council is subject to the disclosure requirements of AS 39.50, the Conflict of Interest Law. An attorney may not serve on the Council and the Commission on Judicial Conduct simultaneously.

If you wish to be nominated to the Judicial Council, subject to an advisory poll and selection by the Board of Governors:

1. complete the nominating petition found on the Bar's website;
2. submit a resume or a letter with a statement of your background, which will be posted on the Bar's website.
