
What Are You Up Against? Common Fronts in a Fraud Investigation



What Are You Up Against? The Multi-Front Investigation





The Yates Memo

- Applies to criminal and civil matters handled by DOJ
- To qualify for <u>any</u> cooperation credit, a corporation must provide "all relevant facts relating to individuals responsible for the misconduct"

What Can You Do To Prepare?




- Have an effective compliance program
- Have an effective document management program
- Identify the team
- Plan and prepare for emergencies

What Can You Do To Prepare Sample Warrant Checklist for Reception

Contact the designated person Obtain credentials from all agents and copy or record the information ☐ Obtain a copy of the search warrant and related materials ☐ Ask the agents to wait in a private location until the designated contact arrives Do not allow the agents to move around the office premises unattended Do not sign any documents or consent to any action Do not remove, discard, or hide anything that might be the subject of the search Do not provide computer passwords or information about employees Do not engage in any other conversation with the agents Be professional and courteous; do not obstruct the search or be confrontational

How Should You Respond? A Time of Magical Thinking



- This is just a subpoena
- This is a good company with good people who would never commit fraud.
- The [insert government customer or regulator] loves us, so this won't go anywhere.
- All we have to do is tell our side of the story and this will go away.
- This is just like civil litigation.
- There is nothing to be done.


How Should You Respond? The First Three Days



- ☐ Contact *experienced* counsel
- Put together the team
- Preserve documents and data
- Inform stakeholders
- Communicate with the government
- ☐ Stop any misconduct
- Don't obstruct

How Should You Respond? Search Warrants

- Immediately contact experienced counsel
- Carefully read the warrant
- Do not consent
- Escort the agents
- Object where necessary, but do not obstruct
 - Outside the scope
 - Privilege
- Monitor and make a record
- Obtain an inventory
- Expect the media



How Should You Respond? The First Three Months



- ☐ Have a plan and then modify it
- Comply with the subpoena
- Investigate
- Manage employees
- Manage press
- Continue to communicate with the government
- Do no harm


How Should You Respond? The End Game

- Nature and seriousness of offense
- Pervasiveness of wrongdoing
- ☐ History of misconduct
- Timely and voluntary disclosure
- ☐ The compliance program
- Remedial actions
- Collateral consequences
- Adequacy of individual prosecutions or other remedies
